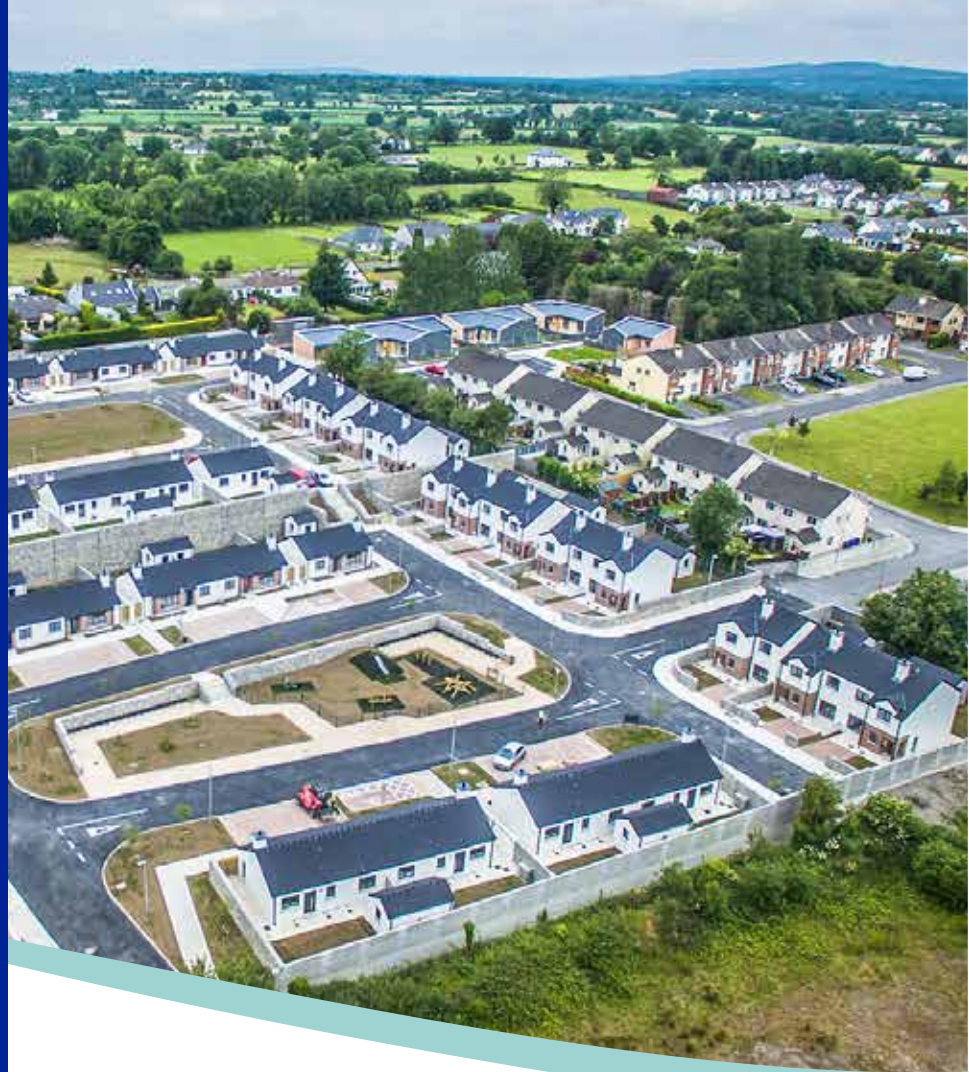

PARKING AT THE NEW HOSPITAL IN MÁLAGA

Málaga (Spain)

Through a partnership, OHLA was awarded, in 2025, a joint contract by Servicio Andaluz de Salud - SAS (Andalucía Health Service) to build the New Malaga Hospital, and to build and exploit its parking facilities.

Construction of the whole infrastructure is scheduled to take 75 months.

This new hospital will consist of 819 individual rooms in a 227.800 m² area. The price of the awarded works amounts to 449 million to be paid by SAS. The hospital will take on the challenges faced by Malaga's hospital system, becoming one of the hospitals in Andalucía that offers the highest-ranking services. It will tend to patients referred from other hospitals in the province and it will carry on specific processes for other Andalusian provinces as well as other Spanish cities.

The lifespan of the parking facilities concession is 23 years. It will manage 1,767 parking spaces for automobiles in an 82.700 m² area. The necessary investment is 77 million and the income –to be received since the beginning of the concession– will derive from parking fees.

FEDERAL HIGHWAY BR-040

Rio de Janeiro and Minas
Gerais (Brazil)

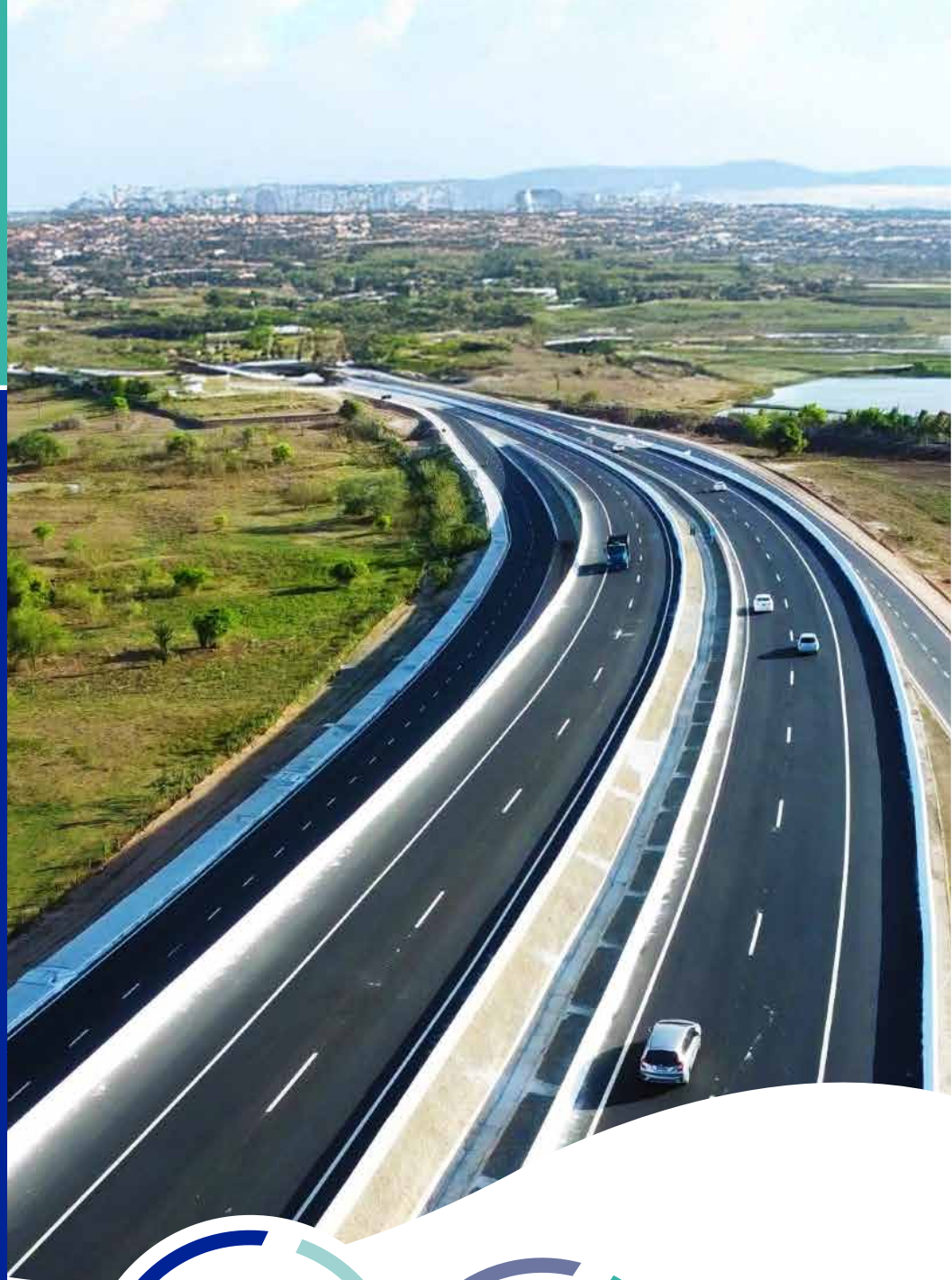
OHLA is part of the concession company responsible for the rehabilitation, expansion, operation, and maintenance of a 219 km federal highway which includes an urban section within Rio de Janeiro, connecting this city to Minas Gerais.

Our client, Agência Nacional de Transportes Terrestres (ANTT), is an entity of the Brazilian Government.

This is one of the most important logistics corridors in Brazil, essential for the transportation of people and goods. The corridor also promotes tourism between two of the country's most dynamic regions.

The project includes major infrastructure interventions, the most significant being the completion of the Serra de Petrópolis climb. This highly technically complex project has long been in demand due to its impact on traffic safety and efficiency.

This 30-year concession requires an initial €1.1 billion investment. The revenue generated since the beginning of the concession comes from toll collection.

ACCESOS NORTE 2 CORRIDOR

Bogota (Colombia)

OHLA is part of the concession company responsible for the design, construction, improvement, operation, and priority maintenance of the existing Accesos Norte highway in the section closest to Bogota.

The project consists of the improvement of a three-lane highway and its expansion to six lanes in a 5.8 km long section; the rehabilitation and duplication of the roadway in a 4.9 km section of Carrera Septima; and the construction of the Perimetral de Sopo with 1.7 km of new layout and 5.5 km of improved roadway. The works include the improvement of road junctions and intersections, an exclusive lane for the BRT system (Bus Rapid Transit System) and the construction of 11.6 km of public spaces (pedestrian bridges, sidewalks, bike lanes, etc.) that will optimize pedestrian mobility.

The project requires €700 million investment and a concession term of 29 years. Revenue derives from a percentage of the tolls collected during the project's concession period. The project is already in operation.

In 2023, an investment fund was brought in to acquire a significant stake in the concession company.

JUSTICE CENTER

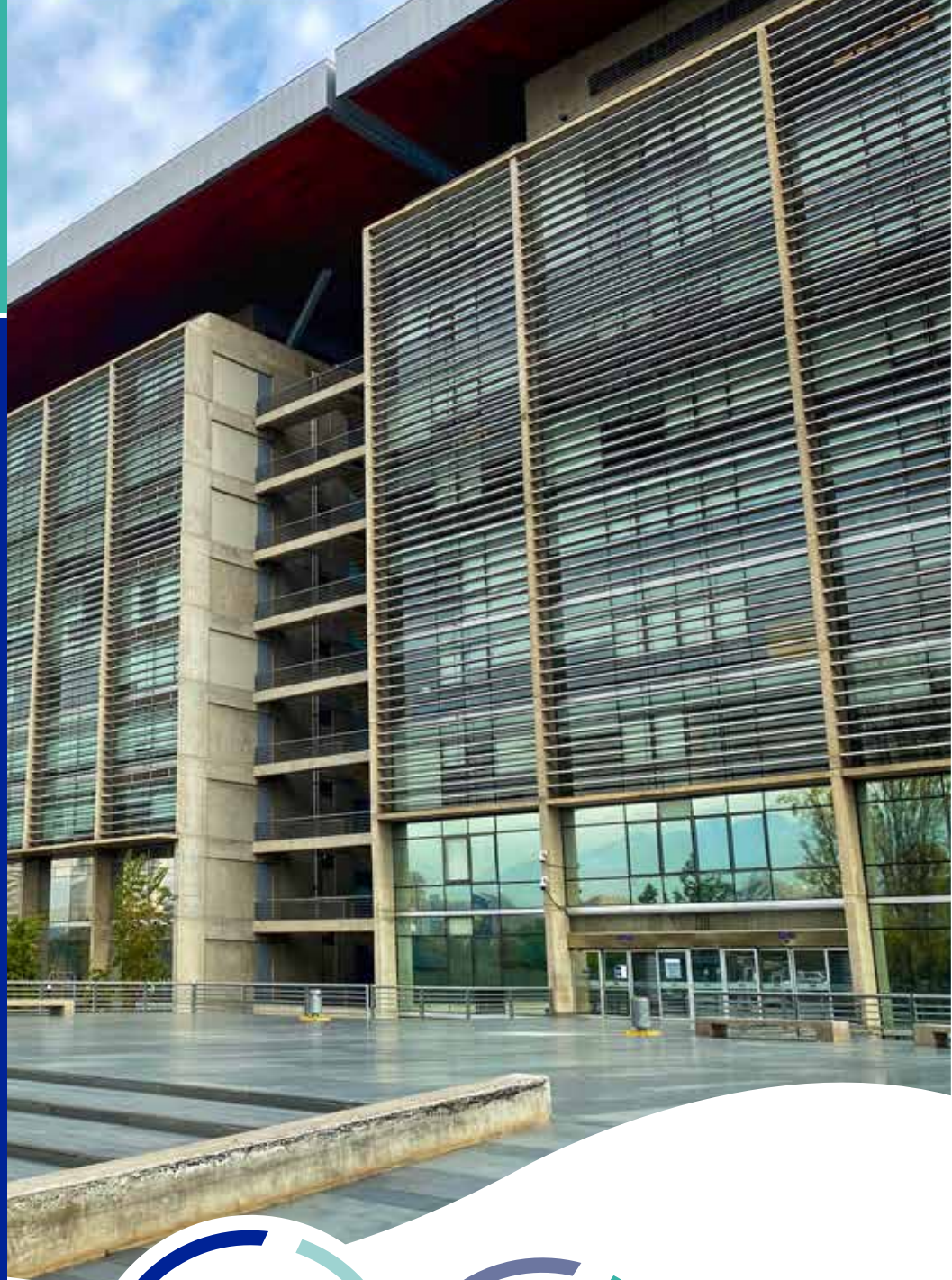
Santiago de Chile (Chile)

In 2004, OHLA was awarded the contract for the new headquarters of the Public Prosecutor Office, the Public Defender's Office, the Guarantee Courts, and the Criminal Trial Courts in Santiago, Chile.

The 117,000 m² Justice Center includes a 12,000 m² parking lot with 250 parking spaces.

The concessionaire provides non-judicial services such as maintenance and cleaning, as well as commercial operations such as parking and cafeteria, among others.

The project's revenue derives from availability payments made by the Ministry of Public Works of Chile.

BIOBIO HOSPITAL NETWORK

Biobio Region (Chile)

OHLA is in charge of the design, construction, maintenance and operation of the infrastructure and facilities, and the installation and maintenance of medical equipment for Santa Barbara, Nacimiento, Coronel, and Lota hospitals in the Biobio region. This project was requested by the Chilean Ministry of Public Works (MOP).

Together, the four hospitals comprise a total surface area of approximately 135,000 m², and will provide 569 beds to the health system, benefiting a population larger than 400,000 people.

The investment required for the project is approximately 400 million euros over a 19-year period. The estimated construction period is 4 years, and the maintenance period is 15 years. Project income derives from availability payments by the MOP.

NACIONAL CANCER INSTITUTE

Santiago de Chile (Chile)

Back in 2023, OHLA was awarded the concession contract for the construction, maintenance, and operation of the National Cancer Institute in Santiago. This contract represents an investment in excess of 300 million euros.

The concession term is 22.5 years. The construction period is 7.5 years, and the maintenance period is 15 years.

The project consists of comprehensive designs, execution of associated civil works, implementation of clinical, administrative, and industrial equipment, as well as the operation of the infrastructure's accompanying basic and special services.

The new National Cancer Institute will serve an estimated population of 11.6 million people and across 86,000 m² and 249 beds. The infrastructure will be equipped with high-tech oncology equipment such as eight linear accelerators. Project revenue derives from availability payments by the Ministry of Public Works of Chile.

SOCIAL HOUSING BUNDLE 2

Several counties (Ireland)

OHLA, a consortium partner, began operating the housing units of Social Housing Bundle 2 (SHB2) public-private partnership (PPP) residential building project in Ireland in 2021 upon completion of construction.

The SHB2 project comprises the construction and maintenance, over 25 years, of 465 sustainable social housing units (110 apartments and 355 houses), with an investment of more than 130 million euros.

The project, subject to the availability payment model (fixed payments by the grantor), is the Government of Ireland's second social housing investment package and covers counties Cork, Kildare, Clare, Galway, Waterford, and Roscommon.

HOSPITAL DE BURGOS

(Spain)

In 2006, OHLA, participating as a consortium, was awarded design, construction, and operation of the non-health services of the new University Hospital of Burgos with a concession term of 30 years.

The hospital has a total surface area of 265,000 m² that houses high-tech equipment, and 744 beds.

Since the beginning of operations in 2011, the concessionary company has overseen the whole management of the works and equipment, as well as 14 non-care activities.

The project's income derives from availability payments and operation-related payments by the regional government of Castilla y León (Spain).

HOSPITAL NIÑO JESUS EXPANSION

Madrid (Spain)

The project is being developed in partnership and is now in the first phase of work and consists of the design and construction of a 9,300 m² hospital building and the operation of the associated underground car park.

The investment in this contract is approximately 40 million euros, and the concession period is 39 years.

POLICE STATIONS IN BARCELONA

(Spain)

In 2005 OHLA was awarded the public-private partnership contracts for the new headquarters of the Horta, and the Sant Andreu districts police stations in Barcelona).

Both stations have a combined surface area of 17,400 m² and the investment amounted to 20 million euros.

The contracts consist of a 21-year term. Operation began in 2007.

The income from both projects derives from availability payments by the Generalitat de Catalunya.

MARINAS OF MARINA UROLA & BARÁ

Guipúzcoa & Tarragona
(Spain)

OHLA was awarded, in partnership, the concession of Marina Urola (Gipuzkoa) in 1997 and Bará Marina (Tarragona) in 2005.

Both concessions have a 30-year term, and operation began in 2000 and 2008, respectively.

They have a total of 1,188 berths and 51 commercial spaces. Total investment amounted to 40 million euros.

The income from both projects derives from the rental and lease of the berths and commercial spaces.
